

**SUPPLEMENT TO: (I) NOTICE OF SEPARATE HEARINGS ON PROPOSED  
SCHOOL CONSTRUCTION PROJECTS, AND (II) NOTICE OF HEARINGS ON  
PROPOSED LEASE, PUBLISHED ON MARCH 18, 2020**

**RICHLAND-BEAN BLOSSOM COMMUNITY SCHOOL CORPORATION.**

Richland-Bean Blossom Community School Corporation (the “School Corporation”) previously published the above referenced notices (“Notices”) with respect to the following separate School Construction Projects:

Operational and Administration Facilities Project – This project includes: (i) acquiring, constructing and equipping a new administration/community building; (ii) improvements, upgrades and renovations to the School Corporation’s existing maintenance and transportation building; (iii) acquiring, constructing and equipping a new storage building; (iv) construction and improvements to sidewalks, including the construction of sidewalks from Edgewood Junior High School to Edgewood High School and out to State Road 46; and (v) other related renovations, improvements and upgrades.

High School Project – This project includes: (i) pool upgrades, improvements and renovations at Edgewood High School; (ii) acquiring, constructing and equipping a new innovative learning center at Edgewood High School; (iii) locker/weight room upgrades, improvements and renovations at Edgewood High School; and (iv) other related renovations, improvements and upgrades.

The Notices provided for separate public hearings with respect to each of the projects and separate public hearings with respect to the lease related to each of the projects to be conducted in room C115A of Edgewood High School (the “High School”), 601 S. Edgewood Drive, Ellettsville, Indiana 47429, at 7:00 p.m., on April 20, 2020.

AS A RESULT OF THE COVID-19 VIRUS AND CERTAIN EXECUTIVE ORDERS OF THE GOVERNOR OF THE STATE OF INDIANA, INCLUDING EXECUTIVE ORDERS 20-04, 20-09 AND 20-17, CONCERNING GOVERNMENTAL UNIT OPERATIONS AND MEETINGS DURING THIS PUBLIC HEALTH EMERGENCY, THE ABOVE REFERENCED PUBLIC HEARINGS WILL BE HELD BY TELECONFERENCE.
