AMENDMENT

THIS AMENDMENT (this "Amendment") effective as of December 19, 2022 (the "Effective Date") by and between PEPSICO BEVERAGE SALES, LLC, and its affiliates and/or their respective subsidiaries collectively comprising Pepsi Beverages Company, with an office located at 1104 S. Post Rd. Indianapolis, IN. 46239 ("Pepsi") and Richland Bean Blossom Community School Corporation, with its principal place of business at 601 S. Edgewood Dr. Ellettsville, IN. 47429 (the "Customer").

WHEREAS, Pepsi and the Customer are parties to the July 1, 2022 (7/01/2022) Agreement commencing on June 30, 2027 (6/30/2022) (as amended on12/19/2022, the "Agreement"); and

WHEREAS, Pepsi and the Customer wish to modify certain terms of the Agreement and memorialize the same in writing.

NOW, THEREFORE, in consideration of these premises and the covenants herein contained, it is hereby agreed that, as of the Effective Date, the Agreement is hereby amended as set forth below. As used in this Amendment, capitalized terms defined in the Agreement and not otherwise defined in this Amendment, shall have the respective meanings assigned thereto in the Agreement.

- Free Product Support Fund. In Years One through Five, Pepsi shall provide Customer with an annual free Product support fund in the amount of One Thousand US Dollars (\$1,000) not to exceed Five (5) consecutive payments (the "Free Product Support Funds").
- 2. The new Contract Start date now is August 1, 2022 (8/01/2022).
- Each party represents and warrants to the other that it has the authority to enter into and perform under this Amendment; and that the execution and performance under this Amendment will not violate any agreements with, or rights of, any third party. This Amendment may be amended or modified only by a writing signed by each of the parties.
- Except as may be expressly set forth herein, all terms and conditions of the Agreement shall remain in full force and effect.
