

Contract Addendum

This contract addendum alters the basic teacher contract for the employment of **Matthew Irwin** as **Assistant Superintendent** by the Board of School Trustees of the Richland-Bean Blossom Community School Corporation by the consent of the parties in the manner permitted by Indiana Code 20-2-8-2.

1. Parties to this Contract and Definition of Terms

The parties to this Contract are the:

“Assistant Superintendent” meaning Matthew Irwin; and the “Board” meaning the Board of School Trustees acting as the governing body of the Richland-Bean Blossom Community School Corporation.

The term “school year” as used in the Contract means a period beginning on July 1 of one calendar year and concluding on June 30 of the following calendar year.

2. Salary and Benefits

As consideration for the performance of the duties and meeting the qualifications established by this Contract, the Board agrees that the Assistant Superintendent shall receive the following:

a. Salary

The Assistant Superintendent shall be paid:

\$121,000 for the School Year beginning **July 1, 2024** and ending **June 30, 2025**.

\$121,000 for the School Year beginning **July 1, 2025** and ending **June 30, 2026**.

b. Vacation

The Assistant Superintendent will be entitled to 15 paid vacation days annually, which shall be taken at times not injurious to the harmonious operation of the School Corporation. Vacation days may accumulate up to twenty (20) and are payable at the time of retirement or severance. Each year, days accumulated over that amount as of June 1 will roll to paid leave accumulation prior to loading new vacation days for the following contract year. Assistant Superintendent paid holidays are: January 1 and one day, Memorial Day, Fourth of July, Labor Day, Thanksgiving and the day after Thanksgiving, Christmas and one day.

c. Personal Leave

In each school year, the Assistant Superintendent shall have fifteen (15) paid leave days given for personal illness, illness of the Assistant Superintendent’s family or personal business. If unused, leave days shall accumulate from year to year, but shall not accumulate to exceed the cap on the accumulation of leave days established by the Board for its administrative employees without the written approval of the Board.

It shall be the duty of the Assistant Superintendent to seek approval of the Board for any accumulation of leave days pursuant to this Sub-Paragraph. Leave days are not

intended as deferred compensation and are to be used only for the purposes of personal illness, family illness, or personal business.

The Assistant Superintendent shall be entitled to transfer thirty (30) accumulated sick days that the Assistant Superintendent is currently entitled to from previous employment. Thereafter, the Assistant Superintendent may transfer thirty (30) sick days each year until the accumulated sick days to which the Assistant Superintendent was entitled in the Assistant Superintendent's last employment are exhausted. Sick days may only be transferred if their use was restricted such that they were to be used only for personal or family illness.

d. Cellular Phone

In addition to the stated salary, the Board shall pay the Assistant Superintendent fifty dollars (\$50.00) monthly as a cellular phone allowance. The Assistant Superintendent shall provide the cellular phone number to the Board for its use in contracting and communicating with the Assistant Superintendent. The Assistant Superintendent is required to have a reliable cellular phone for the completion of his duties. The Assistant Superintendent will pay the expenses for the cellular phone that exceed the allowance amount.

e. Business and Professional Expenses

The Board shall reimburse the Assistant Superintendent or pay for appropriate business and professional expenses. Appropriate expenses shall include mileage reimbursement for the business use of his personal auto at the current IRS rate for business mileage, the cost of membership and participation in state and national professional associations of school administrators, community organizations and expenses related to the Assistant Superintendent's attendance at conferences and activities.

f. Other Benefits

The Assistant Superintendent shall be entitled to any other benefits including early retirement established by the Board of all certified employees of the Board covered by the Master Contract with Teachers. In addition, the Board shall contribute to the premiums for health and dental coverage as outlined in the 2024-25 plan document. The Board shall provide a \$50,000 Life policy and a Long Term Disability policy. The employee cost will be \$1.00 per year for each of these policies.

3. Duties

The Assistant Superintendent shall faithfully perform all duties assigned by the Superintendent.

4. Defense and Indemnification for Acts in Performance of Duties

The Board agrees to provide the Assistant Superintendent with legal counsel selected and paid for by the Board and to defend and indemnify and hold the Assistant Superintendent harmless for all claims, demands and judgments arising out of the performance of his duties set out in paragraph 4 of this Contract to the fullest extent permitted by law.

5. Extension of the Length of this Contract

The contract term shall be **July 1, 2024** through **June 30, 2026**. The parties agree that absent their agreement to the contrary, Indiana Code 20-28-8-3 provides for the terms of any extension of the length of this Contract.

6. Entire Contact of Parties

The parties agree that this amendment to the Regular Teacher’s Contract therefore contains all the agreed terms of employment of the Assistant Superintendent by the Board and will not be modified except in a written document making specific reference to this Contract and the specific provision to be modified. Both parties shall approve modifications to this Contract in the same manner that this Contract was approved. This Contract supersedes all prior and contemporaneous understandings and agreements, both written and oral, with respect to such subject matter.

If required for purposes of compliance with a standard or request of the State Board of Accounts of the State of Indiana, the parties agree that they will execute one or more one-year or multi-year standard teacher contracts to implement the terms of this contract.



2. Assignment

Administrator agrees to serve at the pleasure of the Board with a current assignment of **Principal of Edgewood High School**. This assignment is subject to change upon approval by the Board.

3. Salary and Benefits

As consideration for the performance of the duties and meeting the qualifications established by this Contract, the Board agrees that the Administrator shall receive the following:

a. Salary

The Administrator shall be paid

\$116,000 for the School Year beginning **July 1, 2024 and ending June 30, 2025**

\$116,000 for the School Year beginning **July 1, 2025 and ending June 30, 2026**

b. Other Benefits

The Administrator shall be entitled to any other benefits including early retirement established by the Board of all certified employees of the Board covered by the Master Contract with Teachers. In addition, the Board shall contribute to the premiums for health and dental coverage as outlined in the 2024-25 plan document. The administrator will be entitled to four weeks of paid vacation annually, which shall be taken at times not injurious to the operation of the school programs. Vacation days accumulated as of May 30, 2021 will be capped to that amount and are payable at the time of retirement or severance. Each year days accumulated over that amount as of June 1, will roll to paid leave accumulation prior to loading new vacation days for the following contract year. In addition to vacation days, the paid holidays of New Year's Day, Memorial Day, Fourth of July, Labor Day, Thanksgiving and the next day, Christmas Eve, Christmas, and New Year's Eve are recognized.

4. Duties

The Administrator shall faithfully perform all duties assigned by the Superintendent.

5. Defense and Indemnification for Acts in Performance of Duties

The Board agrees to provide the Administrator with legal counsel selected and paid for by the Board and to defend and indemnify and hold the Administrator harmless for all claims, demands and judgments arising out of the performance of his duties set out in paragraph 4 of this Contract to the fullest extent permitted by law.

The parties to this Contract are the:

“Mental Health Coordinator” meaning Jordan Truax; and the “Board” meaning the Board of School Trustees acting as the governing body of the Richland-Bean Blossom Community School Corporation.

The term “school year” as used in the Contract means a period beginning on July 1 of one calendar year and concluding on June 30 of the following calendar year.

2. Assignment

Mental Health Coordinator agrees to serve at the pleasure of the Board with a current assignment of **Mental Health Coordinator**. This assignment is subject to change upon approval by the Board.

3. Salary and Benefits

As consideration for the performance of the duties and meeting the qualifications established by this Contract, the Board agrees that the Mental Health Coordinator shall receive the following:

a. Salary

The Mental Health Coordinator shall be paid

\$65,000 for the School Year beginning **July 1, 2024** and ending **June 30, 2025**.

\$65,000 for the School Year beginning **July 1, 2025** and ending **June 30, 2026**.

b. Other Benefits

The Mental Health Coordinator shall be entitled to any other benefits including early retirement established by the Board of all certified employees of the Board covered by the Master Contract with Teachers. In addition the Board shall contribute to the premiums for health and dental coverage as outlined in the 2024-25 plan document.

4. Duties

The Mental Health Coordinator shall faithfully perform all duties assigned by the Superintendent.

5. Defense and Indemnification for Acts in Performance of Duties

The Board agrees to provide the Mental Health Coordinator with legal counsel selected and paid for by the Board and to defend and indemnify and hold the Mental Health Coordinator harmless for all claims, demands and judgments arising out of the performance of his duties set out in paragraph 4 of this Contract to the fullest extent permitted by law.

6. Length of this Contract

The School Year shall consist of 200 days including the 185 scheduled teacher days. The contract term shall be **July 1, 2024** through **June 30, 2026**.

7. Entire Contact of Parties

The parties agree that this amendment to the Regular Teacher's Contract therefore contains all the agreed terms of employment of the Mental Health Coordinator by the Board and will not be modified except in a written document making specific reference to this Contract and the specific provision to be modified. Both parties shall approve modifications to this Contract in the same manner that this Contract was approved. This Contract supersedes all prior and contemporaneous understandings and agreements, both written and oral, with respect to such subject matter.

If required for purposes of compliance with a standard or request of the State Board of Accounts of the State of Indiana, the parties agree that they will execute one or more one-year or multi-year standard teacher contracts to implement the terms of this contract.

8. Contract as a Public Record

The parties agree that this Contract is a public record under the Indiana Public Records Law, Indiana Code 5-14-3.


